#### INTRODUCTION 1.

- ZIMTA National Executive convened an emergency National Executive meeting as provided for in the ZIMTA Constitution, Rules and By-laws clause 5.3.5.1.
- The meeting was convened to deliberate on two urgent issues.
- 1.2.1 The remuneration issues and recommendations Provinces.
- 1.2.2 Urgent High Court Cases.
- 1.3. Priority given remuneration provincial to recommendations submitted to National Executive.

#### 2. **OUTCOMES**

- After collating the views from provinces, National Executive consolidated them and prioritised the issues for urgent actioning and which culminated in a declaration herein attached.
- 2.2. The critical labour issues so prioritised are Educators' Salaries, Bonuses and Sector Specific Allowances.
